NTI-kon Ihomalutikaktun GN-kon Havaktolikiyenin Ihomaleogutaen

(July 13-mi 2012-mi –Ikalokni, Nunavumi) Nunavut Tungavik Timeoyum Ikhivaotagiyan Cathy Towtongie uplomi ihomalutikaktok Kavaman Nunavumi ihomaleogutaanik atogoegeagani Havakveoyok Havaktolikiyenin, atuligeaklonilo April 1-mi 2013-mi. Una kigoani GN-kon atogoekniganik Inoenan Havaktukhalikiyenin Havakveanik, inukukhivaleanigilo Inoenan havaktun okaotaoyonik GN-kon naonaepkotaeni. .

Ataniktoeyun Iitokhaeyi Hunaniklikaa Kanatami akhukhaeyok GN-konik ihoakhivaaligeagani havaktikhakheogutigiyatik. Ukoa unipkaan naonaegutaoyun NTI-kon ihomalutigiyaneik atogoekniginik una havakveoyok ihoeliyutaoneakman GN-kon akhun atoenageaganilo havaktikhakheogutigiloaktatik maligak. Havaktikhakheogutigiloaktaan maligak GN-kon atogegani havaagiyakhagiyatik Nakatani 23 iloani Nunavumi Nunatakunikun Agikatigegutaoyum, pikoekmata kavaman havaktikaligaeagani inugeakniginun nalaomayomik havaktukhan.

“Thomalutikaktoga atogoekniganik havakveoyok ayokhaotaoneakman kavamanin atugeagani havaktukhakheogutigiyatik, pivikhakknigilo ayokhayutikhanik pivaleaniginiklo tamaeta havaktun, atuligeaganilo havaagiyageakaktaen Nakatani 23,” okaktok Towtongie.

Napavyaen GN-koni havaan ayoetoni ataneoyonilo inigiyaoyun Inoenalo havaktun 25%-mi aolaginmata, amigaekpaleagitotiklo. Towtongie okaktok NTI-kon kaoyimanahoaginakneakok havateaknaoaklotiklo amigiyagani GN-kon havaagiyaen ukunani kigoani havakveoyok nutaokman Manilikiyinun Aolapkaeyinulo havakveoyuni.
