



Inuktit Education Innovation Fund

Application Overview

The Inuktit Education Innovation Fund (the Fund) was established to provide and enhance opportunities for Inuit to advance Inuit Language and Education in Nunavut's education system.

Funding from the Fund can be applied towards:

- Research on innovative measure, education methods, curriculum development and best practices in the delivery of education in Inuit language and culture; and
- Development of key resources, professional development opportunities and networks that provide for a system of supports to Inuit educators.

Individual Inuit enrolled under the Nunavut Agreement and non-profit organizations are eligible to apply for funding from the Fund. Applicants are asked to submit a proposal with a draft budget of expenses to support the project to ensure that it is in line with the objectives of the Fund.

Applications to the Fund will be accepted until all funding is awarded for the year. Proposals submitted can be for a one-year or a two-year project. Only successful recipients will be contacted on the outcome of their application

How do I apply?

Your first step is to review this document and the application form. Once you complete your application form, use the checklist below to make sure you have included all required materials. Applicants are asked to submit a proposal with a draft budget of expenses to support the project to ensure that it is line with the objective of the Fund.

Your application must include the supporting documents listed below as required per this Application Checklist:

- The Application Form for a Non-profit Organization or Individual Applicant
- A Project Proposal
- A Budget of Expenses

Eligibility

You are eligible to apply to the Fund if you are:

- a) An Inuk enrolled under the Nunavut Agreement and are eighteen years of age or older.
- b) Non-profit Organization

Criteria

Nunavut Inuit and/ or Non-Profit Organizations may submit a proposal for the fund under the following categories:

1. Inuit Language and Culture Education Research,
2. Professional development opportunities on Inuit Language and Culture education, and
3. Curriculum development and resources on Inuit Language and Culture education

NTI retains the final discretion in deciding whether a project is eligible, and the approved amount awarded.

Application Deadline

The period for applications will be open until all funds are spent. Only successful recipients will be contacted on the outcome of their application.

Eligible Expenses

NTI adheres to guidelines set out in the Indigenous Languages Component criteria. For more information, applicants and administrators can visit the Canadian Heritage Website for [eligible expenses](#).

Review Process

Applications for funding will be reviewed by a program committee consisting of NTI and/or Regional Inuit Association staff appointed by the Chief Executive Officer (CEO).

The program committee may consider the following factors when deciding upon merits of each proposal:

- Research and studies to markedly improve the ability to deliver education in Inuktit in Nunavut;
- Development of education methods and materials taking into account; technology that assists Inuit educators in delivering education in Inuktit in a manner that respects and promotes Inuit culture;
- Creates opportunities for Inuit educators to support one another;
- Scope of the proposal reaching all regions and/or underrepresented area of Inuit Language and Culture;
- Previous successful delivery of proposals.
